Pre-Requisites

Students must have completed their Core courses (MK 323, QM 323, OM 323, FE 323) as well as six semesters of college-level Spanish.

Approved Courses

Students take **four** courses for a total of sixteen credits while in Madrid. At least one of the courses must be a management course. A typical course load in Madrid consists of:

- QST IM430 or CAS EC497 Internship and corresponding seminar (mandatory) 4 credits*
- CAS SP 440 Seminar on Contemporary Spanish Topics (mandatory) 4 credits*
- Management Course 4 credits
- Management Course or liberal arts course 4 credits
 *These courses are taken through the Instituto Internacional en España in Madrid. Students take their other courses at the Universidad Autónoma de Madrid (UAM).

Important Notes

- Students may take up to up to **two concentration courses** abroad per concentration; of these, only **one** can fulfill an **A List** requirement.
- Students are unable to fulfill HUB units through courses taken at the Universidad Autónoma de Madrid
